



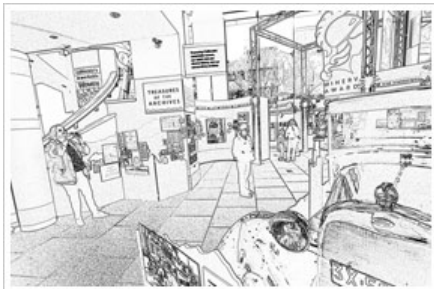
CALBO's Third Annual Leadership & Advocacy Day
