The ICC Los Angeles Basin Chapter Administration Committee – Code Coordination Effort (“LABC-AC”) is taking the lead to facilitate and strengthen code coordination efforts among the various participating chapters, organizations and jurisdictions in California (“CA”). It is the LABC-AC’s goal that increasing collaboration among the various participating CA chapters, organizations and jurisdictions regarding code change proposals will help ensure that the voices of all CA Governmental Member Voting Representatives (“GMVR”) are uniform and consistent. As such, the LABC-AC believes that these efforts will help to enable CA to have a significant impact on the code development process at the national level. The LABC-AC looks forward to working with participating members and interested parties in supporting these efforts and helping to make CA once again become a leader in the code development process.

DISCUSSION

The LABC-AC has been working closely with various CA governmental members that represent participating CA chapters, organizations and jurisdictions engaged in the code development process to evaluate and recommend positions on select code change proposals. With that effort now complete, the LABC-AC is recommending to all CA GMVR to support the consensus voting recommendation for several code change proposals that were individually considered and received a final action during the International Code Council (“ICC”) Public Comment Hearings held on October 23-30 of 2019 in Las Vegas, NV. The LABC-AC hopes that this document will help to serve as a guide for all CA GMVR when evaluating which code change proposals to support or oppose online through the ICC cdpACCESS. This document consolidates and summarizes the desired voting position of various participants to ensure ease of comparison and review for all CA GMVR. The LABC-AC encourages all CA GMVR to participate in ICC’s Online Governmental Consensus Vote (“OGCV”). Your vote is important and will help to further the goal of making CA a leader in the code development process. The ICC Online Governmental Consensus Voting (“OGCV”) period begins **NOVEMBER 18⁹, 2019** and concludes **DECEMBER 5⁶, 2019**.

The table themselves consist of 5 main sections: code change number; code topic, subject or description; public comment hearing results; voting position of each participant; and the consensus voting recommendation. The recommendations are extracted from the more comprehensive shared online excel file used by the LABC-AC to organize the voting position of each participant before, during and after the code hearings.

This column reflects the code change number associated with a code change proposal.

These columns reflect the voting position of the various participating chapters, organizations or jurisdictions from CA.

For a more detailed description, including the full text with strike out and underline, of the code change proposal, refer to the published 2019 Group B Public Comment Agenda – Complete Monograph Dated September 2019.

This column reflects the result of the PCH's final action on a code change proposal. The results of the PCH set the agenda and ballot options for the OGCV.

This column reflects the consensus voting recommendations by the various participating chapters, organizations or jurisdictions from CA following the PCH. A consensus voting recommendation will be reflected here when there is a MAJORITY voting position established for a code change proposal. For the purpose of this document, the term "MAJORITY" is defined as follows:

MAJORITY means that the voting position of **at least 4 or more participants** are the same **and** there is **not more than 1 participant** with a different voting position.

A consensus voting recommendation WILL NOT be reflected here and left blank when MAJORITY cannot be established OR the recommendation is not an allowable voting option.

CONTINUE

Here are 3 examples reflecting when a **CONSENSUS** voting position have been reached to develop a voting recommendation. At least 4 or more participants all the same voting positions and no or one divergent position.

Consensus voting recommendation for the OGCV is reflected in this column. If there is a blank field, this implies that no consensus was reached OR the allowable voting option for that code change is not available. Refer to the individual voting recommendation of participants to guide your voting decisions.

Here is an example reflecting when a **CONSENSUS** voting position has NOT been reached to develop a voting recommendation. It is lacking at least 4 participants with the same voting positions. And even if it has at least 4 participants with the same voting positions, it has two participants with divergent voting position.
