Zone Zero

- Consolidates several Chapters into one place
 - Chapter 7A
 - Chapter 49
- Reprints and Points to Title 14
 - Defensible Space
 - Fire Safe Minimum Regulations
- Elevates to its own Code
 - Part 7
- Reorganizes using the ICC IWUI Model Code

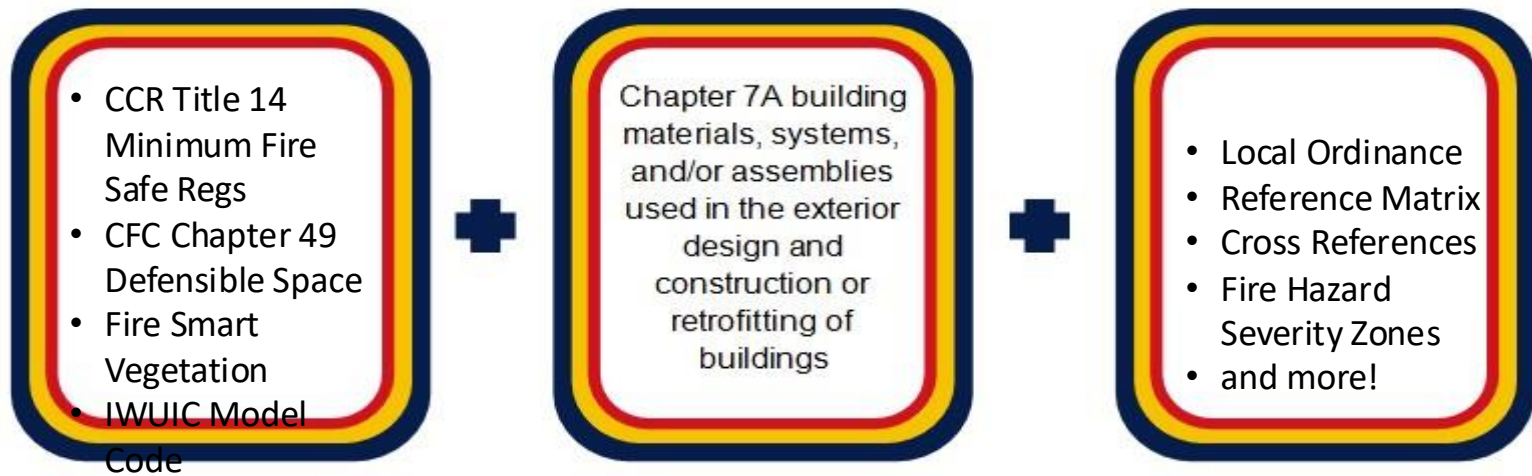
