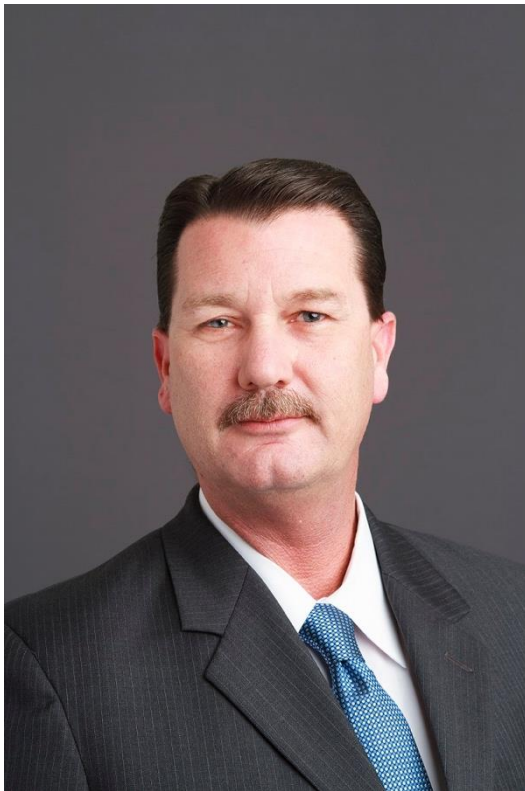

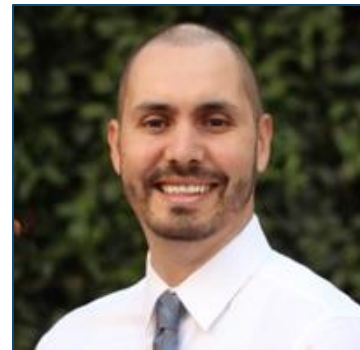

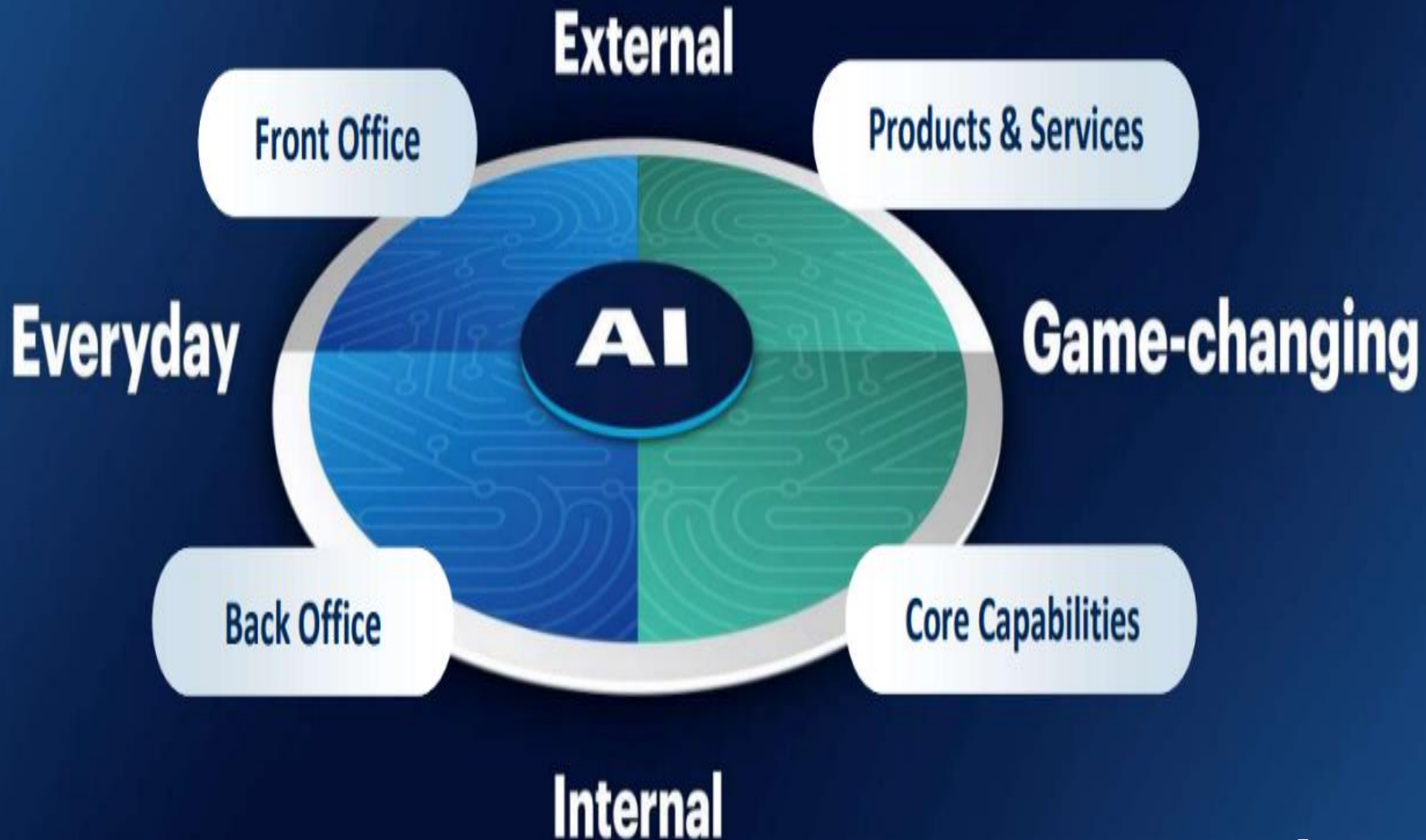

As AI crests the top of the hype cycle, challenges and risks are becoming more evident – but there is real value to be realized

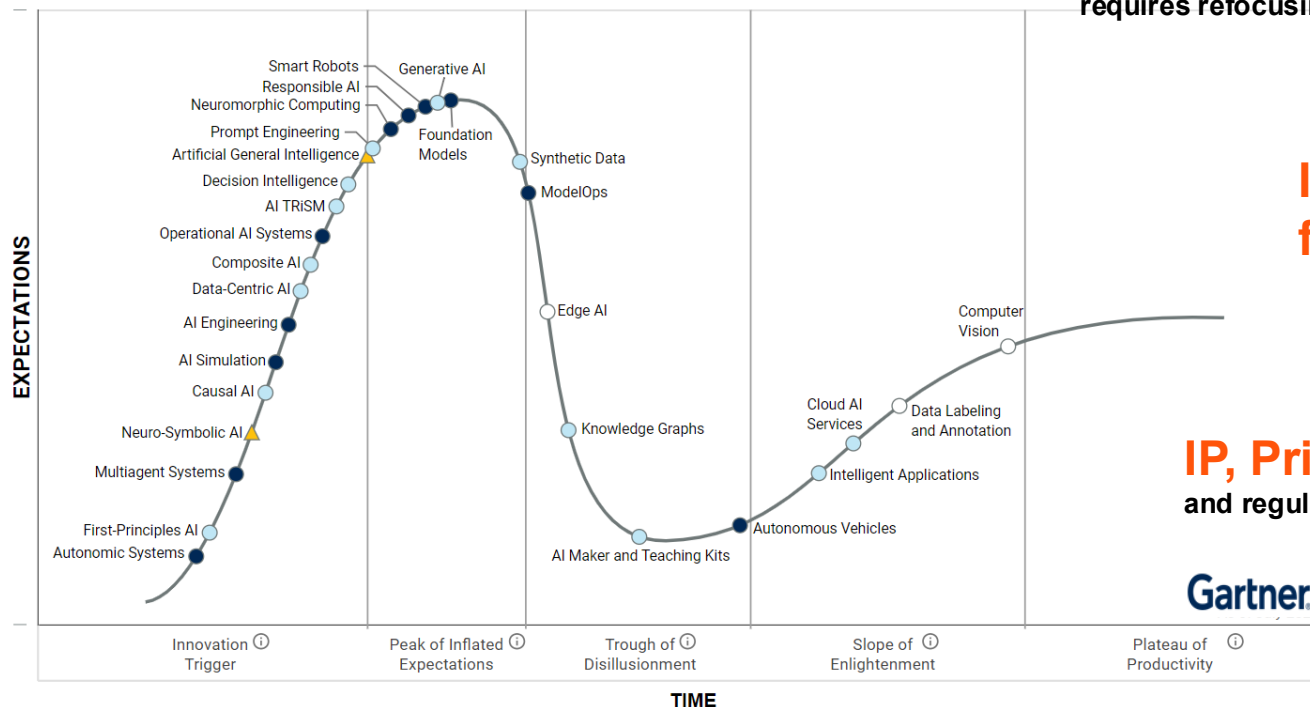

Story of Ask Norwalk

- What problem we faced at Norwalk?
Residents waited long to get information.
- How did I strategize to solve the problem?
- Introduced Ask Norwalk – to bridge the Gap between city and residents.
- Residents can get information in no time for permit history, contractor information and reduce PRR.

AI in Digital Plan Review

- How AI can support in digital plan review and plan analysis.
- Building Inspector can take photo analysis.
- Staff report, ai can write report based on the inspection and save a lot of time for inspectors to do the actual work.
- Current difficulty in the system – (data spread across multiple systems)
- What can solve – simplified system integrating seamlessly with systems to group information (centralization)
- AI can help search the building code for information and references in different parts of the code related to the same issue and save plan checkers time on code research.

FY 2024 – 1,241 Public Records Requests

- 508 Related to Building Permits
 - From: Realtors, Construction Companies, Residents
 - Before: 40 minutes to fulfill. After: One minute



FY 2025 – Anticipated 600 Public Records Requests

- 276 Related to Building Permits

Phone Calls for Community Development / Building & Safety

- From 40% to → 32% of phone calls
- Heaviest call volume between 7:30 a.m. – 9:00 a.m.
 - Most Common Call – Inspections
 - Questions about deviating standards.



Building Permits for 6004 Painter Ave

Building Permits for 6004 Painter Ave:

1. Encroachment Permit:

- **Description:** HHS Communication to bore and trench for Time Warner Cable/Spectrum along the east side of Painter Ave. Locate existing CATV vault tie-in to trench W to place 6' of 3" conduit. Bore SE to place 712' of 3" conduit. Bore S to place 45' of 3" conduit and place new Charter 17x30" vault. Bore south to place 1' of 3" conduit. Traffic control as shown on the attached plans. Work on Painter Ave. and Philadelphia St.
- **Status:** Closed.

2. Development Review Counter Permit:

- **Description:** 92-sf addition to existing storage located to the rear of SFR.
- **Status:** Approved

How tall can my house be?

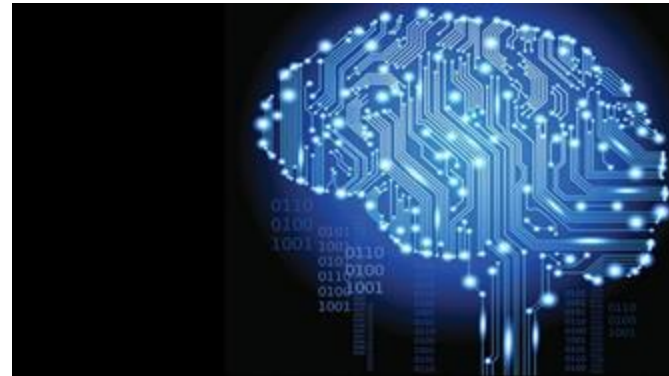
