**Advanced Scoping of the 2016 CBC Chapter 11B:

This course provides attendees with a working understanding of the 2016 updates to the disabled-access provisions contained in the California Building Code, with an emphasis on the interpretations and intent of selected administrative, scoping and updated technical requirements. Discussion, lecture, and exercises assist users of the code with inspections and plan reviews. Supporting documents (ANSI, Guidelines, Best Practices, etc.), tools of the trade, and inspection techniques are explored throughout the course. Local jurisdictional staff (building department, public works, parks and recreations, etc.), architects, designers, contractors, and business owners/managers are encouraged to attend.
