### California Commission on Disabled Access With The San Francisco Access Appeals Commission Releases The Accessibility Checklist

On June 24, 2015 the California Commission on Disabled Access (CCDA) formally releases the Accessibility Construction Inspection Checklist for Trained Building Inspectors.

The legislative request contained in Senate Bill 1608 and government code 8299.06 that CCDA provide a checklist for trained building inspectors prior to July 1, 2010. A CASI and CALBO Access Committee member was called to the table on Monday June 23, 2014 by Building Standards Commission (BSC) Executive Director Jim McGowan and CCDA Executive Director Steve Castellanos to put together a checklist that will meet the requirements and be used by build-

ing inspectors. A committee was formed with Steve Dolim (Vice Chair of the CCDA Commission) as chair to the committee with 11 committee members, three from CALBO, one from BSC, one from HCD, three from CCDA, one from AIACC, and two from DSA. Many of the committee members were also CASI members.

This committee completed the task in less than eight months with final release of the checklist a year after the request from BSC & CCDA Executive directors.

The checklist is available on the CALBO, CASI, BSC, and CCDA websites to download for free.

#### **Intervening Code Cycle Amendments Effective July 1, 2015**

The 2013 California Building Code (CBC) intervening code cycle has been usable but not required as of January 1, 2015. On Wednesday July 1, 2015 the intervening code cycle amendments take effect and shall apply

to all new construction, alterations and additions to public accommodations, public buildings, commercial buildings, public and private schools, public housing and site improvements that are permitted after July 1, 2015.

These changes have been previously provided in your code supplement blue errata sheets as amendments to the code. Please see sheet 3 for the changes to 11B and accessibility.
